**1. DATA CONTROLLER**

Your personal data can be processed by TAV Esenboğa Yatırım Yapım ve İşletme A.Ş. (the “**Company**”), in the capacity of the data controller, in the context explained below, in accordance with the Personal Data Protection Law no. 6698 (the “**Law**”).

**2. PURPOSE OF PROCESSING YOUR PERSONAL DATA**

Personal data we obtain from you shall be processed in line with the fundamental principles stipulated in the Law, within the personal data processing framework drawn in articles 5 and 6 of the Law, and with the purposes stated below, the major purposes being: Carrying out corporate communication and corporate social responsibility activities, organizing lotteries or contests, specifying marketing strategies, administration of events and organizations, executing campaign, promotion and introduction processes, measuring and reporting campaign performances; and where you have provided your explicit consent, carrying out marketing-related data analytics studies, carrying out personal promotion and marketing activities, and running campaigns, promotions, introduction processes, and activities based on customer satisfaction or experience.

- Making necessary studies/works and conducting related business processes in order to provide related persons with the opportunity to benefit from the products and/or services offered by our Company and/or for and on behalf of our Company,
- Planning the activities required for recommending and promoting the products and services offered by our Company and/or for and on behalf of our Company, by customizing them according to taste, usage habits, and needs of related persons

**3. PARTIES TO WHOM YOUR PERSONAL DATA SHALL BE TRANSFERRED AND THE PURPOSES OF TRANSFER**

Your personal data which shall be collected may be disclosed to our business partners in Turkey and abroad, our shareholders, mainly the Aéroports de Paris Group, our group companies, our suppliers, legally authorized public authorities, and competent private persons, in order to achieve the Purposes, in accordance with the personal data processing terms and conditions set forth in articles 8 and 9 of the Law.

**4. METHOD AND LEGAL REASON FOR COLLECTING YOUR PERSONAL DATA**

If you contact our Company, your personal data shall be collected in an electronic and/or physical environment, by means of mail, printed and online forms, e-mail, telephone, website, mobile and applications, call center/communication center, and corporate social media channels.

Furthermore, your personal data shall be collected if a contract exists with a legitimate interest as regulated in articles 5 and 6 of the Law, based on the legal reasons of explicit consent.

#### **5. AS THE OWNER OF PERSONAL DATA, YOUR RIGHTS DEFINED IN ARTICLE 11 OF THE LAW**

We hereby notify that, as a data subject, you have the following rights according to article 11 of the Law:

- To learn whether your personal data are processed or not,
- If your personal data are processed, to request information in relation thereto,
- To learn the purpose of processing your personal data and whether they are used in compliance with the purpose,
- To know the third persons, to whom your personal data are transferred in Turkey or abroad,
- In case your personal data are processed incompletely or incorrectly, to request the correction thereof and to request that any operation carried out in this context is reported to the third persons, to whom your personal data are transferred,
- Despite being processed in compliance with the provisions of this Law and other relevant laws, to request that personal data shall be erased or destroyed in the event that the reasons for the processing no longer exist and any operation carried out in this context is reported to the third persons, to whom your personal data are transferred,
- To object to the occurrence of an outcome against you, if any, by analyzing the data processed solely through automated systems,
- If you sustain any damage due to unlawful processing of your personal data, request indemnification of damages.
